## COLLEGE

Lake Tahoe Community College is a small two-year college with approximately 2,500 students in total and 60 international students. ## COMMUNITY

The College is located in South Lake Tahoe, California, a small resort community in the beautiful Sierra Nevada Mountains at 6,200 feet above sea level. The town's main industries are casinos, tourism and skiing. The permanent population is about 30,000. Outdoor recreation is year-round at Lake Tahoe. Students are within minutes of three ski resorts, with twelve others to choose from around the lake. Summer brings water sports and access to an extensive network of hiking and mountain biking trails. The sun shines an average of 274 days a year giving students plenty of chances to get out and explore the Sierra Nevada

## HOUSING/TRANSPORTATION

LTCC does not offer on-campus housing but many rental options are available in the community. You should arrange for living accommodations as soon as your F-1 visa is granted. All F-1 international students coming to the U.S. to study can enter the U.S. up to 30 days before the start date for their program listed on their I-20 form. We strongly recommend that students use this early arrival option to have enough time to adjust to time change, to get to know the new area and to finalize housing arrangements.

Public transportation is available via Tahoe Transportation District and students receive a free bus pass with a valid student ID.

## FULL-TIME ENROLLMENT



International students are required to enroll in and complete at least 12 units per quarter of attendance. International students are not eligible for financial assistance, and they must comply with all requirements of the USCIS, SEVIS and Lake Tahoe Community College. We recommend you take advantage of our counseling services in planning your coursework throughout your attendance at Lake Tahoe Community College. As a condition of your F1 visa you will need to show sufficient funds to cover all expenses without employment.

## REQUIREMENTS FOR ADMISSION OF INTERNATIONAL STUDENTS

International student admission applications are considered each quarter. Admission is contingent upon completing the application process in a timely manner. International students are not accepted for intensive English language study only.

**The non-refundable application fee is \$100.**

**Lake Tahoe Community College accepts F-1 students provided they have met the following requirements. Your application must be submitted with the following items by the deadline to be considered:**

	Requirement	Documentation to be Submitted
1	Minimum Age	You must be 18 years of age or older. Provide proof of date of birth such as a copy of your passport, birth certificate, or other official document.
2	Previous Education	You must have the equivalent of an American high school education. You must submit transcripts from all high schools attended. Transcripts from institutions outside the United States must be translated into the English language.
3	English Proficiency	You must demonstrate that you are fluent in the English language. Please submit <u>one</u> of the following: <ul style="list-style-type: none"> <li>▪ TOEFL score report: minimum score of 55 on the Internet-based version;</li> <li>▪ IELTS score report: minimum of 5.5;</li> <li>▪ GTEC CBT score report: minimum 1055;</li> <li>▪ Cambridge English Assessment test: B1 level or higher;</li> <li>▪ iTEP English Proficiency test 3.5 or higher;</li> <li>▪ diploma, transcript, and recommendation letter proving completion of Intensive English Language School;</li> <li>▪ This requirement may also be satisfied through verbal interview with LTCC ESL Director and Academic Counselor.</li> </ul> <p><b>Note:</b> If English is the primary language of your home country, you do not need to submit any of the above stated documents;</p>
4	Financial Resources	You must have assured a minimum of \$16,000 in United States currency for each year you expect to attend Lake Tahoe Community College. A student should not assume he/she can live on less than this amount per year. Students on an F-1 visa are not allowed to work off-campus in most cases. Provide recent (last 6 months) confirmation of ability to meet all financial obligations including tuition and school fees, housing/living arrangements, and textbooks. Applicants who have local support willing to take financial responsibility for their living expenses while at the College will need to demonstrate the ability to cover only the academic cost of tuition and books. Written statement from the sponsor will be required. Lake Tahoe Community College does not have a financial aid program for international students
5	Health	You must be in good health prior to arrival in the United States. Provide evidence of a <u>recent (6 months)</u> physical examination with your admission packet.  In addition, you will also be required to have a tuberculosis screening upon arrival. LTCC will accept results from tests conducted within the last 6 months if documentation shows a PPD (Mantoux skin test for tuberculosis administered and reported in millimeters in the United States).
6	Letter	Write a personal letter containing information about your interests, your career goals, as well as your future plans. Submit the letter in English. Letter must be typed and signed by hand.
7	Immigration Documents	Please provide a copy of your passport page(s) showing name, picture, date of birth, and expiration date. Transfer students should also provide copies of their visa, I-94 arrival/departure card, and current I-20 form.
8	Application	Complete all sections of the International Student Application form.
9	Application Fee	You must submit a \$100 <b>non-refundable</b> application processing fee with your application.
10	Medical insurance	You will be required to have international health/medical coverage in place and active on the first day of classes. Medical costs are very high and you must have insurance to protect yourself. Prior to enrollment, submit evidence of medical coverage to cover the term of your stay here.

#### NOTIFICATION OF ACCEPTANCE

Upon satisfactory receipt of all items, your application for admission as an International Student will be reviewed. If approved, we will send you an I-20 (Certificate of Eligibility for nonimmigrant [F1] Student Status), together with a letter of acceptance. Approved students will be notified by email.

***If your application has not been completed, you will not be considered for admission***

## SEVIS

The Student and Exchange Visitor Information System (SEVIS) is a web-based system for maintaining information on international students and exchange visitors in the U.S. After receiving your I-20 from LTCC, you must pay SEVIS a \$200 non-refundable, processing fee. F-1 students will need to show proof of paying this fee before a visa will be issued.

The I-901 form can be completed online with credit card payment and printed receipt or download the I-901 and mail with payment. You must bring proof of this payment to your embassy appointment.

## LIVING EXPENSES AND SCHOOL FEES

Prospective students and/or sponsors must complete a Declaration and Certification of Finances with the appropriate documentation stating that they have a minimum of \$16,000 (U.S. dollars) per year for their living and school expenses. This is the amount of financial resources you must demonstrate for admission and SEVIS reporting purposes.

**Your actual costs for room, board, books, supplies, transportation, and other living expenses will vary based on where you decide to live and the courses you decide to take.**

Tuition and enrollment fees will be collected at the time of registration for each quarter based on the number of units in which you enroll. **You will not be asked to pay the full amount of tuition upon arrival in the United States.**

## COUNSELLING AND ORIENTATION

All new students must attend a New Student online orientation at [www.ltcc.edu/orientation](http://www.ltcc.edu/orientation) and an International Student orientation. Upon arrival you must also meet with an academic advisor to discuss educational and career goals and develop a plan for their achievement. Please contact the International Student Program Office to make an appointment with a counselor.

Upon your arrival in the United States and no later than the first day of class, please visit the International Student Office to verify your presence. The Designated School Official will certify your enrollment status to SEVIS. **Please note that you are allowed to enter the United States no sooner than 30 days prior to the first day of class.**

## MAINTAINING YOUR STATUS

Once you are in the United States, it is important that you do not violate the conditions of your visa to maintain your status. F-1 students must maintain full-time status by enrolling in at least twelve (12) units per quarter. You must notify the International Student Office immediately if you change your address or other contact information. You must also obtain written authorization from the International Student Office prior to leaving the country for holidays or other breaks.
