## PERSON WHO TESTS POSITIVE FOR COVID-19 SHOULD:

- STAY HOME for at least 5 days.
- · Once symptoms are resolved <u>and</u> after at least 5 days of isolation have been completed, test again with LTCC; if the test is negative you can return to campus (no sooner than the 6<sup>th</sup> day).
- · While on campus, a N95 or KN95 mask will be required until a full 10 days from the date of onset of symptoms is completed.

### EMPLOYEES WHO ARE EXPOSED TO SOMEONE WITH COVID-19:

(Vaccinated)

- Participate in weekly COVID testing.
- · Continue to follow LTCC mask guidelines.
- · If symptoms develop, test and stay home.

### EMPLOYEES WHO ARE EXPOSED TO SOMEONE WITH COVID-19:

(Unvaccinated)

- STAY HOME for at least 5 days after your last contact with a person who has COVID-19.
- Once at least 5 days of quarantine have been completed, test with LTCC if no symptoms; if the test is negative and you have no symptoms you can return to campus no sooner than the 6<sup>th</sup> day.
- · While on campus you must strictly adhere to LTCC's masking guidelines.

#### **DEFINITIONS**

#### **COVID POSITIVE:**

- Day 0 = Day symptoms begin or day the positive test was administered for asymptomatic or pre-symptomatic individuals.
- Day 1 = First full day after symptoms developed or day after positive test administered. (This starts the count for isolation.)

#### **COVID EXPOSURE:**

- Day 0 = Day of initial exposure.
- Day 1 = First full day after exposure.

**ISOLATION:** The time period for a person who tested positive.

POSITIVE TEST: Positive COVID test (PCR or Rapid Test) on date of sample collection.

**QUARANTINE**: This time period is for a person who has been exposed and is unvaccinated. The time begins from the date of the sample collection that resulted in a positive test result.
