

Interstate Attendance Agreement Application

Students approved for the Interstate Attendance Agreement are exempted from non-resident tuition and instead pay a reduced rate of \$93/unit. Applications are reviewed on a first-come, first-served basis. There is a cap on the number of students that are accepted each year. Only students from the following zip codes may be eligible: 89402, 89451, 89450, 89413, 89448 and 89449. Students that are declined are welcome to attend, but must pay non-resident tuition. Students may reapply the following quarter if their application was denied.

All documents used to establish Good Neighbor eligibility must include:

- f The student's name (or parent's name if student is under 19 and unmarried)
- *f* **The student's** <u>physical address</u> in **NEVADA** (or parent's physical address if student is under 19 and unmarried). P.O. boxes will not be accepted.
- f be dated at least one year and one day prior to the start of the quarter

Some documents that may work are:

- Nevada tax forms from the previous year
- Mortgage, title or rental agreements showing the physical address where the student lives
- Utility or other bills showing a Nevada physical address
- Nevada voter registration
- Nevada driver's license
- > Automobile or other insurance showing a Nevada physical address
- > Documentation of having received Nevada State services such as unemployment, rehabilitation, welfare, etc.
- Moving bills showing a destination of a Nevada physical address
- Checking or savings accounts held at a Nevada bank or credit union
- License from a Nevada professional practice
- Jury duty summons for a Nevada court
- Selective Service registration with a permanent Nevada address
- > Nevada listed as the home of record on a military Leave and Earning Statement (LES)
- Petition for divorce as a Nevada resident
- > Federal tax forms listing a Nevada physical address
- Employment contracts with a Nevada business
- Records of attendance at a Nevada college or university as a resident of that state (payment of resident fees)
- > You may have other documentation that meets the necessary criteria.
- If you moved to Nevada directly from California during the past year, you may also want to provide documentation showing that you were previously a California Resident

It is strongly recommended that you submit <u>at least</u> two documents along with your application.

Lake Tahoe Community College reserves the right to limit the number of Interstate Attendance Agreement students accepted per quarter. Students who are declined are welcome to attend, but must pay non-resident tuition. Students may reapply the following quarter if their application was denied.
