This will be an on-site visit to your institution in which the team will gather additional information via interviews, data requests, and meetings to discuss the Core Inquiries. We anticipate the Focused Site Visit will be a shorter visit with a smaller team; nevertheless, we ask you hold the entire week for flexibility in scheduling meetings.

To allow the team adequate preparation for the visit, the Institutional Self-Evaluation Report must be submitted no later than **December 15, 2023**. As your ACCJC liaison, I am happy to assist with any questions you may have throughout this entire process.
