Overall students are performing lower in correspondence (RSP) courses and students of color are generally performing lower than white students, with the exception of online courses (Asian and Black students outperformed white students in online classes). However, many of the numbers are statistically insignificant due to low sample size.

Yes, both REL 103 and REL 107 is overdue for Title V updates. This is most likely due to only having adjunct faculty in the discipline who don't have time or knowledge about the updates. The dean is notifying the faculty.

LTCC has an in person instructor for REL 107, however, it is often cancelled due to low enrollment. The religion discipline is attempting to offer in person and online options, but often has very low enrollment.

REL 103 is offered every quarter with consistent enrollment in RSP. REL 103 is also offered online and runs with fairly small numbers (average class size around 10). REL 107 F2F has been cancelled twice in the last two years due to low enrollment.

No, there is not a FT faculty in the religion department
