HISTORICAL IMPROVEMENTS

2012 - CURRENT

ADMINISTRATIVE

- EMERGENCY MANAGEMENT PLAN (EMP) RE-STRUCTURED TO COINCIDE WITH THE NATIONAL INCIDENT MANAGEMENT (NIMS) PROTOCOLS
- EVACUATION MAPS WERE POSTED THROUGHOUT CAMPUS
- EMERGENCY BACKPACKS AND RADIOS DEPLOYED PER EMP
- KNOX BOXES WERE INSTALLED TO EXTERIOR CAMPUS LOCATIONS ALLOWING EMERGENCY RESPONDERS ACCESS TO ALARMS WHEN CAMPUS IS CLOSED
- CONTRACTED FOR AFTER HOURS AND WEEKEND SECURITY PATROLS
- DEVELOPED MAPPING OF ALL UTILITY EMERGENCY SHUT-OFFS
- BOARD POLICIES AND ADMINISTRATIVE PROCEDURES CURRENTLY BEING UPDATED
 - 3500 (CAMPUS SAFETY)
 - 3501 (CAMPUS SECURITY AND ACCESS)
 - 7600 (CAMPUS SECURITY OFFICERS)





BUILDING IMPROVEMENTS

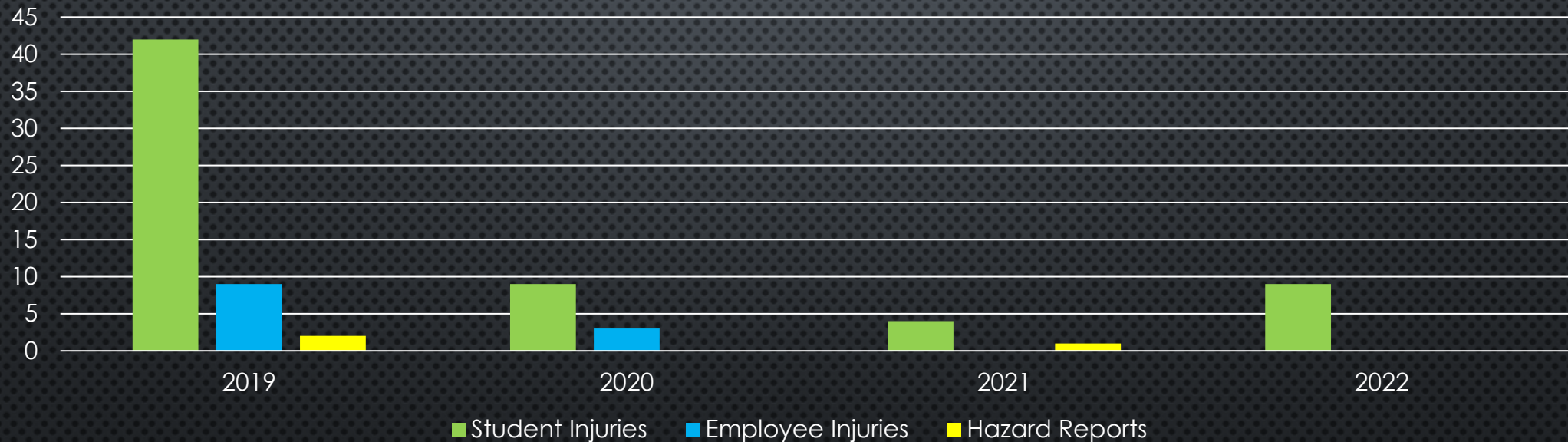


- BLINDS ADDED TO CLASSROOMS TO ALLOW FOR SHELTERING IN PLACE
- LOCKDOWN ABILITY ADDED TO CLASSROOMS
- PHONES WITH EMERGENCY NUMBERS ADDED TO ALL CLASSROOMS
- UPGRADED INTERIOR WIFI AND CELLULAR IN COMMONS AND LMUC
- ADDITIONAL HEATED SIDEWALKS TO ENHANCE SAFETY ON CAMPUS
- FIRST AID AND AED LOCATED AT KEY LOCATIONS AROUND CAMPUS
- ALL EXTERIOR DOORS REKEYED TO RETAIN CONTROL OF ACCESS TO CAMPUS

TRAINING

- PLAN AND IMPLEMENT FIRE AND SHELTER IN PLACE DRILLS
- SMALL GROUP TRAININGS COMPLETED
- SECURITY OFFICERS HAVE COMPLETED STATE TRAINING AND MEET THE REQUIREMENTS OF A SECURITY GUARD EARNING THEM THE ABILITY TO WEAR A BADGE
- HOSTED VARIOUS TRAININGS ON CAMPUS SUCH AS ALICE (ACTIVE SHOOTER TRAINING), MASS CASUALTY TRAINING WITH BARTON, AND SAREX (STATEWIDE SEARCH AND RESCUE TEAMS)
- COMPLETED DE-ESCALATION TRAINING FOR FACULTY AND STAFF — FEBRUARY 2020



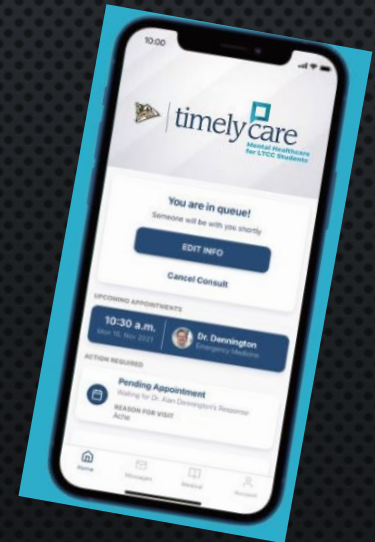
TECHNOLOGY

- LTCC ALERTS – IMPLEMENTED WITH ONGOING TRAINING
- ADDITIONAL ALARM COVERAGE
- SECURITY CAMERAS ADDED TO AREAS SUCH AS UNIVERSITY CENTER, PE, ELC, CDC, AND STUDENT CENTER
- ACCESS CONTROL ADDED TO FRONT OF CAMPUS, CDC, PE, AND ELC

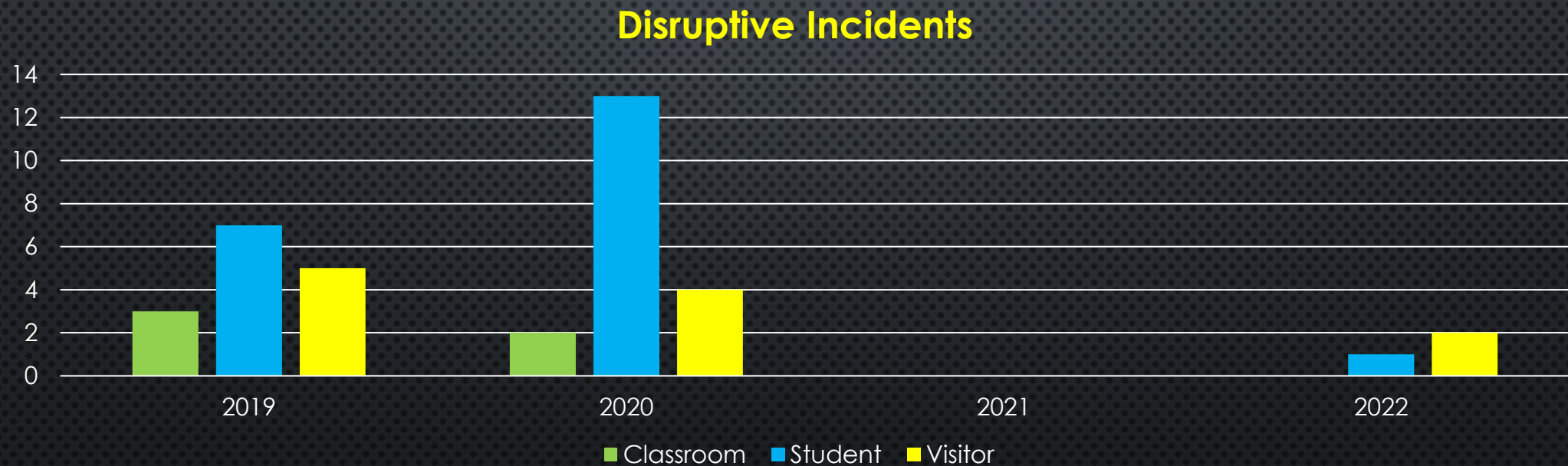


BEHAVIORAL INTERVENTION

- IMPROVED COHESIVE APPROACH TO BEHAVIORAL ISSUES ON CAMPUS WITH SECURITY INVOLVEMENT IN LEADERSHIP
- DEVELOPMENT OF BEHAVIORAL INTERVENTION TEAM (BIT) TO PROACTIVELY HANDLE DISCIPLINE ISSUES
- MENTAL HEALTH SERVICES PROVIDED FOR STUDENTS AND EMPLOYEES
- LEGAL, OFFICE OF INSTRUCTION, AND STUDENT SERVICES MET TO UPDATE STUDENT CONDUCT, DISCIPLINE, AND GRIEVANCE POLICIES



CAMPUS SAFETY AND SECURITY BEHAVIORAL ISSUES IDENTIFIED



2020 Reports related student incidents are concentrated between January through March 27

NEXT STEPS

CAMPUS SAFETY AND SECURITY – NEXT STEPS

- CREATION OF FULL-TIME SAFETY AND SECURITY DIRECTOR RESPONSIBLE FOR:
 - SAFETY AND HAZARDOUS MATERIALS REPORTING
 - FIRE DRILLS AND PREPAREDNESS
 - SUPERVISE SECURITY PERSONNEL
 - MAINTENANCE OF SECURITY PLANS
 - OVERSEE ACCESS CONTROL
 - PRIMARY POINT OF CONTACT FOR “AFTER HOURS” CONCERNS
 - LIAISON WITH LOCAL PUBLIC SAFETY AGENCIES
 - CAMPUS SECURITY REPORTS SUCH AS CLERY ACT REPORT

CAMPUS SAFETY AND SECURITY – NEXT STEPS

- COMPLETE ROLL OUT OF ACCESS CONTROL ON CURRENTLY OUTFITTED DOORS
- ENHANCE SECURITY CAMERA COVERAGE ON EXTERIOR DOORS
- CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN
 - ACCESS CONTROL
 - SECURITY CAMERAS
- UPDATE EMERGENCY MANAGEMENT PLAN (EMP)
