While Fall enrollment information has been previously shared, this is the first look now that the census date has passed.

Census date at most institutions is around the second week of classes, usually marking the end of the add/drop period.

This 'snapshot' of data is used for state and federal reporting. However, the numbers will change some as the term continues.



Historical Lookback at Fall WSCH Values



Fall 2019 has become a 'baseline term' given that it was the last Fall prior to COVID, however it is important to remember that it was a banner term at the College after years of growth.


Fall 2019 - Pre-COVID
Fall 2020 - Campus closed due to COVID
Fall 2021 - Campus opened but impacted by Caldor Fire, resurgence of COVID
Fall 2022 - Campus open, no issues
Fall 2023 - Campus open, no issues to date

Fall Term Credit Course Modality Trend

Percentage of Face to Face (F2F) non-Physical Education course offerings (51%) have increased since the return to campus in Fall 2021 (44%).

However, challenges remain for F2F courses, including:

Fall Term Credit Course Modality Trend Cancellation Rate Comparison


Distance education courses are less likely to be cancelled due to low enrollment or lose an instructor which is more likely to happen in F2F courses.

Other F2F challenges include finding a qualified instructor who is local and available during the scheduled class times. Credit Courses Taught by LTCC Faculty excluding RSP and Physical Education courses



- Percentage of students taking at least one F2F course: Fall 2019: 55% Fall 2023: 43%




Fall to Fall Persistence Rate First-Time, Full-Time Matriculants



The Fall term listed on the chart is the term in which the student first registered and the percentage displayed reflects the persistence rate of those returning in the subsequent fall term.


Example: Of the 133 students who were first-time, full-time in the fall of 2022, 79 registered for Fall 2023. (59%)

Persistence Rate of Fall 2022 first-time, full-time students returning <u>this</u> fall (59%) is lower than the previous year's cohort (64%) with the difference of 6 students.



Rising Scholars Program (RSP) – Fall Term Enrollment Trend







Athletics Program: Soccer and Cross Country

Soccer: 47 student-athletes

- -> 28 males, 19 females

Cross Country (first year): 5 student-athletes

- -> 3 males, 2 females
- -> Average units: 14.4
- -> Unit Range: 12 19


