- Mentioned building a relationship with South Tahoe High School
- Discussed building partnerships with local Non Profit Organizations

- New position to TRTA as Youth Program Manager
- 10 years in Wilderness Education in Tahoe
- 5 years as a Wilderness Educator in Boulder, Colorado
- Mentioned her work with ADA Trail in Tahoe Meadows
- TRTA leads 16-18 backcountry trips for youth on The Tahoe Rim Trail
- Looking to work with LTCC helping WEOL students with internships at TRTA
- Mentioned TRTA Executive Director Lindsey Schultz desire for trail building classes
- Trail Building classes would be regional to locale they were being built
- Spoke on TRTA grant for diversity/equity
