## 2026–2027 Dependent Student Verification Worksheet

Your 2026–2027 Free Application for Federal Student Aid (FAFSA) or California Dream Act Application (CADAA) was selected by the grant agency for review in a process called verification. The law says that before awarding financial aid, we must ask you to confirm the information you reported on your application. To verify that you provided correct information, our financial aid office staff will compare your application with the information on this worksheet and with any other required documents. If there are differences, your application may need to be corrected. You must complete all applicable sections and sign this worksheet, attach any required documents, and submit the form and other required documents to the Financial Aid Office at Lake Tahoe Community College (LTCC). LTCC may ask for additional information. We cannot award financial aid until verification is complete.

### C. Verification of 2024 Income for Student

**Important Note:** The instructions below apply to the student.

#### 1. Student Tax Filers - 2024 IRS Income Tax Return Information

**Check the box that apply:**

- The student will not file and is not required to file an IRS 1040 (for income under \$14,600 in 2024).
- The student has not yet filed 2024 taxes but made more than \$14,600 in 2024 and is required to file.
- The student will provide the school a signed copy of their 2024 IRS 1040, or Tax Return Transcript(s).

**1. Parent Tax Filers – 2024 IRS Income Tax Return Information**
