SUBJECT: Crime Awareness and Campus Security Act of 1990
 Annual Report on Crime on the Campus for Calendar Year 2022

Law requires the college to publish three (3) previous years' statistics regarding crime on campus in mandated categories. Effective April 2017, the *Handbook for Campus Safety and Security Reporting 2016 Edition*, published by the US Department of Education, informs the reportable categories of the crime statistics presentation. As shown below, the District continues to have few reported incidents of crime. The arrest statistics are compiled by the **City of South Lake Tahoe Police Department (SLTPD)** and the **EI Dorado County Sheriff Department (EDCSD)** and reported to the college.
